Whereas, the aforesaid Incharge Junior Assistants appeared in the type test, which was conducted by the Concerned Distinct Industrial Training Institute, in terms of SRO-308 of 2008 dated: 16/10/2008 and have qualified the test by registering more than 25 words speed per minute on computer Keyboard as per the result statement submitted by Chief Education Officer concerned vide letter No. CEO/A/NT/8909/17, dated. 22706/2017 and No. CEO/A/NT/21382/17 dated 04/10/2017.

Now, therefore, as approved by the Divisional Departmental Promotion Committee, sanction is accorded to the regularization of the aforesaid 19 (nineteen) I/C Junior Assistants as Junior Assistants in the pay band of Rs.5200-20200 with grade pay of Rs.1900/- (Pre-Revised) w.e.f. 01/10/2017.

- The regularization shall be without prejudice to the final outcome of the case, if any sub-judice/impugned or pending before the Hon'ble Court or any other court and other orders, if any passed by the competent authority, which may not be immediately within the knowledge of this Directorate.
- The Chief Education Officer must ensure that there is nothing adverse against the officials from the VoK/Crime/Police.
- The officials must necessarily be holding substantive genuine appointment and un-interrupted service. The benefit of regularization shall not be allowed in case the official/s are under suspension or in case of the official/s against whom departmental proceeding may be pending or whose work and conduct may not be satisfactory.
