Whereas, Mtr. Jameela Akhter was appointed in the Department as teacher in District Anantnag and subsequently posted in BHS Singhpora on contractual basis on 24/10/2006 and regularized by Department on 09/06/2015; and

Whereas, prior to availing of benefit of her regularization as teacher she remained un authorizedly absent from her legitimate duties w.e.f 09/09/2014; and

Whereas, the said contractual teacher was provided opportunities to resume her duties, but she failed to do so, which indicates that she is not interested to work more in the Department; and

Whereas, the issue was placed before the Designated Committee in its meeting held on 27/10/2021 and after examining the case the committee took the following decision:

"process for disengagement/termination w.e.f 09/09/2014".

Now, therefore, pursuant to the decision of the committee Mtr. Jameela Akhter, Teacher, BHS Singhpora, District Anantnag is hereby disengaged/removed from the service of the state with immediate effect.

Sub: Un-authorized absence case of Ms. Nighat Hussain, Teacher, BMS Soura District Srinagar and removal of services thereof.

Whereas, Mtr. Nighat Hussain, Teacher, BMS Soura District Srinagar remained un-authorizedly absent from her legitimate duties w.e.f 01/09/2012; and

Whereas, she was served several notices by the Drawing & Disbursing officer concerned on 23/05/2018 followed by another notice dated: 11/07/2018 to resume her legitimate duties which she failed; and

Whereas, the said teacher was again provided an opportunity to be heard and was asked to present herself before this Directorate alongwith statement of defense within a period of 15 days through a Joint Show Cause Notice issued by this office vide No. DSEK/Estt/III/B-Trs/MZ/150/021/1121 dated 06/07/2021 which was also published in print media viz **Daily Aftab and Kashmir observer** on 09/07/2021; and

Whereas, instead of presenting herself before this Directorate with statement of defence she continued to remain absent from her legitimate duties, which indicates she is not interested to work more in the Department; and

Whereas, remaining un-authorizedly/continuously absent from legitimate duties by a Government employee attracts action in terms of article 113 of J&K Civil Services Rules (Volume I) of 1956, reads as under:-

Article 113

“After five years of continuous absence on leave an officer is considered to be out of state employee.”

Whereas, the issue was placed before the Designated Committee in its meeting held on 27/10/2021 and after examining the case the committee passed the following decision:

“to process for termination of services under Article 113 of CSR”.

Now, therefore, pursuant to the decision of the designated committee **Mtr. Nighat Hussain, Teacher, BMS Soura District Srinagar** is hereby removed from Government service in terms of Article 113 of J&K Civil Services Rules (Volume I) of 1956 read with Rule 30 (vii) of J&K CCA Rules 1956.
