Subject: Placement of PG Masters as I/C Lecturers in the discipline of English.

Government Order No. 903 - Edu of 2017

D a t e d : 26.10.2017

On the basis of seniority/ eligibility, forty seven (47), PG Masters as per Annexure-A to this order, are hereby placed as I/C Lecturers in the discipline of English, in their own pay and grade, with charge allowance as admissible under rules, for a period of six months or till the posts are filled up on regular basis through PSC/ DPC, whichever is earlier.

These placements, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of court case, if any, that may be sub-judice in the court(s) of Law.

These I/C Lecturers shall report to concerned Directorate of respective Divisions within 21 days from the date of issuance of this order. If any I/C Lecturer(s) fails to join within the stipulated period of time, it shall be presumed that he/she has foregone the elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The concerned Directorate of School Education will allow them to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotees as mentioned against each.
- (ii) Any of the promotee who has already been working either as I/C Headmaster or I/C Lecturer in other discipline may not be allowed to join as I/C Lecturer (English).
- (iii) The in-service candidates who have acquired P.G Degree are required to avail the leave during his/her service and after obtaining proper permission from the competent authority. In case during this verification, it is proved that they have failed to obtain the permission from competent authority or they had not availed proper leave/ deputation, their officiating placement shall be deemed to have been cancelled ab-initio without any further notice. The Director School Education shall immediate revert them back to their original place of posting.
- (iv) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired he/ she has acquired such degree are valid, shall be determined by the concerned Directorate of School Education.

- (v) The officer(s) is not involved in any adverse case(s) Vigilance/Crime e.c) which fact shall be ascertained by the concerned Directorate of School Education Department.
- (vi) That the in-service candidates who have done projects during the period he/she has acquired degree certificate has obtained leave, otherwise salary for the said period shall be deducted from the salary of concerned incumbent.

The concerned Directorate of School Education Department shall ensure that all the above conditions are fulfilled by the official (Promotee) before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and such cases shall be referred to the Administrative Department for further attention. Those officials, who fulfill the conditions and are allowed to join, be posted by the respective Directorates as per the transfer policy of the department.
