Whereas, the Administrative Department vide letter No. Edu-I/332/2017 dated 10.07.2017 forwarded the list of 08 candidates selected as Teachers for District Cadre Kupwara pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Secy/Sel/2017/5270-76 dated 09.06.2017 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas vide this office Notification No. DSEK/Estt/III/B-Trs/6646-49 dated 07.09.2017, these selectees were advised to deposit the requisite papers in this Directorate within a period of 15 days, however, **only One (01)** candidate responded to the notification leaving **07** candidates who failed to do so;

Whereas the matter was taken up with the Administrative Department vide this office letter No. Estt-III/B-Trs/7817 dated 21.12.2017 for conveying necessary instructions;

Whereas, the Administrative Department vide letter No. Edu-I/332/2017 dated 15.03.2018 conveyed instructions for operating waiting list against the slots which became available due to non-joining of candidates for the post of Teacher in District Cadre Kupwara in pursuance to Advertisement Notification No. 03 of 2014 dated 30.12.2014 under Item No. 319 ;

Whereas, vide this office notification No. DSEK/Estt/III/B-Trs/2152-54 dated 30.05.2018, two candidates (against whom recommendations were not kept withheld) from the waiting list who were making place in the selection zone against the slots which became available due to non-joining of some candidates under SC Category in District Cadre Kupwara, were informed to deposit their undertakings and other requisite documents in the Directorate of School Education, Kashmir within a period of 10 days;

Whereas, in response to the notification dated 30.05.2018, **only One** candidate deposited requisite papers alongwith undertaking on the devised format duly attested by the 1st Class Magistrate, leaving One candidate who failed to do so;

Now, therefore, sanction is hereby accorded to the provisional appointment of BHUSHAN DUTT (whose full particulars are reproduced below) as Teacher in District Cadre Kupwara against the available slot in in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 (Pre-revised) admissible under SRO-93 dated 15.04.2009. The candidate is required to report to the Chief Education Officer, **Kupwara** within **Ten (10)** days from the date of issuance of this appointment order for seeking further posting on her own risk and responsibility till the verification/authentication of all relevant documents/certificates is received from the concerned issuing authorities:

The Chief Education Officer, Kupwara shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates. ¶
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn. The provisional appointee shall be on probation initially for a period of Two years.

The provisional appointment of candidate is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.


