- 4. That the present promotion In-Situ shall not change/ affect the existing designation/ seniority/ duties of the employees.
- 5. That the benefit of the promotion in-Situ shall not be applicable, if the official has earlier foregone regular / functional promotion or will forego his functional promotion in future;
