  - b) Matriculation/ Date of Birth Certificate.
  - c) Academic/ Professional Qualification Certificate(s).
  - d) Health certificate from the concerned Chief Medical Officer of the District.
  - e) Certificates from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under any Self-Employment Scheme has been availed by the appointee.
  - f) Valid relevant Category Certificate, if any applicable.
  - g) Migrant Certificate from the Competent Authority.
- 3. The appointee shall furnish an undertaking in terms of SRO-412 of 2009, dated: 30-12-2009 issued by Revenue Department, and also that the documents furnished by the candidate are genuine and shall be liable for termination of the service/ criminal proceedings, in case any of the document(s) at any time is/are found fake/ forged.
