Sub: Promotion of Junior Librarian as Librarian.

Whereas, the Divisional Departmental Promotion Committee meeting was held on 06/01/2018, among other agenda points, the matter regarding promotion of eligible Junior Librarian on the available Librarian posts was placed before the committee as Agenda item No: 10.

Whereas, the DPC agreed to the promotion of **09 (nine)** Junior Librarians, according to the strict seniority, subject to the obtaining of fresh vigilance clearance from GAD (Vigilance).

Whereas, four (04) Junior Librarians, figuring at S.No.01, 03, 06 and 09 in the DPC approved list (in whose favour vigilance clearance was received from GAD Vigilance) were promoted w.e.f.30/07/2018 vide order No: 994-DSEK of 2018 Dated: 30/07/2018, No: 995-DSEK of 2018 Dated: 30/07/2018, No: 1210-DSEK of 2018 Dated: 12/09/2018 and No. 1499-DSEK of 2018 Dated: 20/12/2018.

Whereas, Administrative Department vide letter No: Edu-I/313/2009-IV Dated: 23/10/2018 has conveyed fresh vigilance clearance issued from GAD (Vigilance) vide O.M. No: GAD (Vig) 14-NOC/2018-Edu-II Dated: 12/10/2018 in favour of Mohd Akram Sheikh, Junior Librarian, HSS Noorpora, figuring at S.No.07, in the DPC approved list.

Now, therefore, as approved by the Divisional Departmental Promotion Committee and cleared by the GAD (Vigilance), sanction is hereby accorded to the promotion of Mr. Mohd Akram Sheikh Junior Librarian whose particulars are given against his name as Librarian in the pay level 6 (35400-112400) in Divisional Cadre Kashmir with effect from **30/07/2018**, for seniority purpose and with monetary benefit from the date he actually joins on the higher post.

The promotion of Junior Librarian to the post of Librarian shall be subject to fulfilment of following explicit conditions:-

- 01 If the Junior Librarian as named above in the promotion order, is on subsequent verification, found not eligible for such promotion, this order will not confer any right on him and his promotion on the higher post (made hereby) shall be rescinded in that case. It will be **personal responsibility** of the Chief Education officer/Drawing and Disbursing Officer concerned to verify particulars of the promotee with reference to his original service record and ensure that the date of 1st appointment as Junior Librarian as well as other particulars recorded against his name (here in above in this order) are correct. Variation if any found should be brought to the notice of this Directorate for further orders. In that case the Junior Librarian shall not be relieved for his promotion on the higher post.*

- 02 The promotee must necessarily be holding substantive genuine appointment and un-interrupted service. The benefit of promotion shall not be allowed in case the promotee is under suspension or in case the departmental proceedings may be pending against him or his work and conduct may not be satisfactory.
- 03 Superior claim vis-à-vis inter-se-placement of the promotee for re-determination of seniority in the cadre of Junior Librarian, if any shall be submitted to this Directorate within a period of one month through proper channel.
- 04 The promotion shall be without pre-judice to the final outcome of the case, if any sub-judice/impugned or pending before the Hon'ble High Court or any other court and other orders, if any passed by the competent authority which may not be immediately within the knowledge of this Directorate.
- 05 The Chief Education officer concerned must ensure that there is nothing adverse against the promotee from VOK/Crime/Police/CID.
- 06 The promotee is required to report at his new place of posting within twenty one days from the date of issuance of promotion/adjustment order, failing which, the order shall automatically stand rescinded ab-initio in his favour without issuing formal cancellation orders.


