Subject:- Deputation of un-trained in-service Teachers Regular Course at IASE (Formerly Govt College of Education, Srinagar) during the Session 2018-20.

ORDER NO. 960 DSEK OF 2018 DATED 23/ 07 / 2018

Whereas, vide this Office Notification No. Estt-III/NG/A/B.Ed./2018/51 Dated 14/05/2018 applications on prescribed format were invited from desirous un-trained graduate/post-graduate Teachers who were not registered for B.Ed. Course through IGNOU/NIOS or any University/College during the Session 2018-20;

Whereas, pursuant to the said Notification, the Chief Education Officers have furnished the consolidated list of such un-trained inservice Teachers alongwith their application forms, within the prescribed time;

Whereas, on the basis of feedback received from Chief Education Officers, a tentative list of desirous in-service un-trained graduate/post-graduate Teachers for undergoing B.Ed. (Regular) Course was uploaded on the website of this Directorate and Notification on the subject was issued vide No. Estt-III/NG/A/190-95 Dated 02/07/2018 and was published in the daily news paper for inviting objections/clarification as well as clear cut certificate from Chief Education Officers regarding non-registration of applicant-Teachers for B.Ed. Course;

Whereas, the objections/clarifications furnished by the Chief Education Officers were examined and appropriate modification / correction were made wherever required/applied for;

Whereas, the Chief Education Officers also intimated that some of the listed Teachers have already registered themselves for B.Ed. IGNOU/NIOS (Distance Mode) and are therefore, not eligible for deputation to (IASE) Government College of Education, Srinagar in pursuant to the Notification;

Now, therefore, sanction is hereby accorded to the deputation of **70 (Seventy)** in-service un-trained Teachers (who are not registered for B.Ed. Course through IGNOU/NIOS or any other University/College) to undergo B.Ed. Regular Course at (IASE) College of Education, Srinagar during the Session **2018-20** as detailed in **Annexure** to this Order subject to the following conditions:-

- 1. That the deputation is made without prejudice to due consideration of superior claim, if any reported;
- 2. That the deputee (un-trained in-service Teacher) has not been nominated for such training earlier;

- 3. That none of the un-trained Teachers listed in the Annexure to this Order holds a un-regularized, FAT / fake / fraudulent / un-regularized ReT / un-regularized Migrant Substitute status or is under suspension or is not in active service. In the event of such an instance, if any detected on re-verification, the selectee shall not be relieved for the Course;
- 4. That a deputee who may be working against long or short leave arrangement or against a lien post of migrant Teacher shall not be relieved for the Course;
- 5. It shall be the responsibility of the concerned Chief Education Officer and the Head of Office/Institution to verify the particulars of each deputee by reference to his/her Service Book and the original testimonials, before relieving him/her for the Course. He should also satisfy himself that the qualification/date of Ist appointment / adjustment / promotion/regularization as Teacher and other particulars as recorded in the deputation order are correct. The date of first appointment referred to herein shall mean date of appointment as Teacher or promotion/adjustment as Teacher and date of regularization in case of regularized FAT/ReT/Migrant substitute and not date of entry into service on a non-Teaching Class IV post. In case a Teacher selected under reserved category, valid category certificate of him/her being a member of a particular Class/category as on 1st January 2018, shall be verified before relieving him/her for the Course;
- 6. The Chief Education Officers/Drawing and Disbursing Officers concerned shall ensure that the deputees who have acquired graduation during service /honorarium period have been allowed to do so by the competent authority and leave whatever kind due has been sanctioned/entered in the service records accordingly.
- 7. In case any variation is found in the particulars and a deputee is found actually not eligible for such deputation the same shall be brought to the notice of this Directorate for clarification within seven days and no such Teacher shall be relieved for the Course;
- 8. The selected Teachers will be required to join the B.Ed. Course in the College of Education, Srinagar by or before **27/07/2018**. A deputee who fails to report to the Principal, College of Education, Srinagar by the specified date shall forfeit his/her claim for deputation to B.Ed. and the deputation in his/her favour shall be liable to be cancelled and the same shall invariably be recorded in their service records and their application for such deputation in future shall not be entertained;
- 9. That each deputee must have passed his graduation or an equivalent degree before the cut of date for receipt of applications viz **01/01/2018** through a recognized University approved by the UGC/University of Kashmir and also holds substantive/genuine appointment;
- 10. Any deputee who may not be in a position to join the Course on health or other grounds, he/she may be allowed to do so only after obtaining the formal cancellation orders from this Directorate within seven days from the date of receipt of this Order;
- 11. The Chief Education Officers shall put in place in advance an appropriate mechanism to make up for the gaps resulting in various Schools as a result of this deputation order;

12. The Principal, (IASE) College of Education, Srinagar shall furnish attendance/performance report of the in-service pupil Teachers to the Principal, SIE Srinagar enabling the Institute to help keep tabs on their progress/achievement during the Session. The SIE in turn, shall Institute a suitable and effective monitoring mechanism for the purpose and put up periodical reports in the matter to this Office;

The Drawing and Disbursing Officers/Chief Education Officers shall implement the order after observing all the conditions as laid down hereinabove for deputation of in-service Teachers for B.Ed. Regular Courses during the Session 2018-20. It shall be the personal responsibility of concerned Chief Education Officers/Drawing and Disbursing Officers to clarify the observations indicated in the Annexure to this Order.

Before implementing/endorsing this Order, the Chief Education Officers shall personally verify the list of registration of Teachers of IGNOU/NIOS and other relevant records available in their offices, and shall ensure that the deputee is not registered for B.Ed. through IGNOU/NIOS (Distance Mode) or any other University/College. In case if any deputee is found registered for B.Ed. through IGNOU/NIOS (Distance Mode) in that case such deputee shall not be relieved for B.Ed. deputation until further orders from this Directorate. Any complaint if, received in this behalf by this Directorate shall be viewed seriously.
