Whereas, the Administrative Department vide communication No. Edu-I/86/2019 dated 09.05.2019 forwarded selection lists of candidates for the post of "General Teacher" in various Districts Cadres of Kashmir Division including District Cadre Budgam in pursuance to SSB's advertisement Notification No. 06 of 2017 dated 28.12.2017

Whereas, provisional appointment orders were issued in favour of all such candidates against whom recommendations were either not kept withheld by the SSB or released subsequently

Whereas, pursuant to DSEK Order No. 462 - DSEK of 2020 dated 31/12/2020 and Order No. 298 -DSEK of 2020 dated 14/08/2020 provisional appointment in respect of Arshad Saboor Dar and Samar Ahmad Akhoon was cancelled due to their non-joining resulting with two slots got accrued

Whereas, the matter was taken up with the Administrative Department vide this office communication No. DSEK/Estt/III/B-Trs/83 dated 21/01/2021 for obtaining authorization for operation of waiting list against these accrued slots

Whereas, Administrative Department vide communication No. Edu-I/86/2019-I dated 25/02/2021 conveyed approval for operation of waiting list in favour of Two candidates namely Rubeena Zaffar and Masrat Samoon figuring at S.No. 1 and 2 in the waiting list against ST Category in District Cadre Budgam in terms of SRO-60 of 2018 dated 02.02.2018 and desired to issue appointment orders in their favour strictly in terms of SRO-202 of 2015 dated 30.06.2015 as amended vide S.O. 194 dated 17.06.2020 after satisfying yourself about the genuineness of appointment.

Now, therefore, sanction is hereby accorded to the provisional appointment of Rubeena Zaffar and Masrat Samoon (whose full particulars are reproduced below) as General Teacher in District Cadre Budgam in pursuance to SSB's advertisement Notice No. 06 of 2017 dated 28.12.2017 (Item No. 004) in the minimum of Pay Level 5 (Rs. 29,200-92,300/-), as admissible under SRO-193 of 2018, dated 24.04.2018 against the available slots. The conditions of probation, pay and allowances and fixation of initial tenure of the appointees shall be governed by Jammu & Kashmir Probationer (Condition of Service, Pay & Allownces) and Fixation of Tenure Rules 2020 issued vide S.O. 192 of 2020 dated 17.06.2020 read with Government Order No. 654-JK (GAD) of 2020 dated 19.06.2020.

The appointment of the candidates as "General Teacher" is subject to the following conditions:-

- The appointee shall be governed under New Pension Scheme as per SRO 400 of 2009 dated i. 24.12.2009.
- In case, at any stage it emerges that the certificates/any relevant document furnished/produced by the ii. selectee is/are fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate and to this effect the provisional appointee shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate;



iii. The appointees shall give an undertaking by way of affidavit duly attested by the 1<sup>st</sup> Class Judicial Magistrate to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.

iv. The appointees shall give an undertaking in shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled *ab-initio* and he/she shall have no claim of his/her appointment.

The appointees shall report to the Chief Education Officer Budgam within a period of 21 days from the date of issuance of this appointment order for seeking further posting orders. In case of failure to join within stipulated time period, the appointment shall be deemed to have been cancelled abinitio without any further notice in terms of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated 04.12.2019.

The Chief Education Officer, Budgam shall allow the candidate to join on the post after observing all the conditions of appointment order and after verifying the following certificates (in original):

- Character and antecedents certificate from Additional Director General of Police (CID)
- Qualification certificate viz Degree/Marks
- Permanent resident certificate
- Age and health certificate
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-Self Employment Scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority in order to ensure that the qualifications as reflected in the selection list is according to the genuineness marks card /qualification certificate.

The provisional appointment order of the candidates shall be confirmed only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary shall be drawn till issuance of confirmation order.

The inter-se seniority of the appointee in the particular grade/service shall be fixed giving due consideration to their inter-se merit in the selection in terms of Rule 24 of CCA Rules, 1956.
