**Sub: Un-authorized absence case of Mr. Mohammad Akbar Seero, Peon HS Doabagh, Rafiabad Baramulla and removal of service thereof.**

Order No: 97 DSEK of 2023

Whereas, Mr. Mohammad Akbar Seero, Peon HS Doabagh, Rafiabad Baramulla remained un-authorizedly absent from his legitimate duties w.e.f. 13/05/2017; and

Whereas, the incumbent was provided enough opportunities by the Drawing and Disbursing Officer concerned to resume his duties which he failed; and

Whereas, the said official was provided one more opportunity by this office on 18/05/2021 followed by a joint show cause notice on 06/07/2021 asking him to present himself before this Directorate along with statement of defense within 07 days from the date of issuance of notice ; and

Whereas, neither he presented himself before this Directorate nor responded to these notices, indicating thereby that he is not interested to work in this Department; and

Whereas, the issue was placed before the Designated Committee in its meeting held on 11/12/2021 and after examining the case the committee took the following decision:

***"Process termination under Article-128 J&K CSR of 1956"***

Whereas, in light of decision of committee, Mr. Mohammad Akbar Seero, official was served pre-termination notice by this office on 12/03/2022, for furnishing/submitting statement of defence within 7 days, but he again failed to respond to the said notice; and

Whereas, the official has already completed more than 5 years of continuous/un-authorized absence which attracts action as warranted under Article 113 of J&K Civil Services Rules (Volume I) of 1956, which reads as under:-

**Article 113**

***"After five years of continuous absence on leave an officer is considered to be out of state employee."***

Now, therefore, pursuant to the decision of the committee, **Mr. Mohammad Akbar Seero, Peon HS Doabagh, Rafiabad Baramulla** is hereby removed from the service of the State in terms of Article 113 of J&K Civil Services Rules (Volume I) of 1956 and rule 30(vii) of J&KCCA rules 1956.
