Pursuant to the selection made by the J&K Service Selection Board, Jammu and conveyed by the Administrative Department vide above referred communication, sanction is hereby accorded to the provisional appointment of below named two candidates (whose particulars are reflected against them) as "Junior Assistant" in District cadre Baramulla under RBA category in pursuance to SSB's advertisement Notice No. 03 of 2016 dated 30/06/2016 in the minimum of Pay Level 4 (25500-81100/-). The condition of probation, pay and allowances and fixation of initial tenure of the appointee shall be governed by Jammu & Kashmir Probationer (Condition of Service, Pay & Allowances) and Fixation of Tenure Rules 2020 issued vide S.O 192 of 2020 dated 17/06/2020. The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any Court of competent jurisdiction or any order which may not be presently within the knowledge of this Directorate.

In terms of Government order No. 528-JK (GAD) of 2021 dated 21/06/2021, the matter was taken up with the concerned quarters with regard to obtaining of verification of character and antecedents reports of selectees. The character and antecedents report issued by the Dy. Supdt. of Police (Hqrs) CID J&K (V/B) vide No. CID V/B/2021/Final/50388-394/EDU, dated 16/Nov/2021 and No. CID V/B/2021/Final/50388-394/EDU, dated 11/Nov/2021 respectively with the remarks that there is nothing adverse against the individuals:

The appointment of the candidates as "Junior Assistant" is subject to the following conditions:-

- I. The appointees shall be governed under New Pension Scheme as Per SRO 400 of 2009 dated 24/12/2009.
- II. In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is/are/ fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate and to this effect the provisional appointee shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate;
- III. The appointees shall give an undertaking by way of Affidavit duly attested by the 1st Class Judicial Magistrate to the effect that they will not apply for transfer in any case for whatsoever reasons during the temporary service from the place where they have been adjusted/posted.

The appointees shall report to the Chief Education Officer, Baramulla within a period of 21 days from the date of issuance of this appointment order for seeking further posting orders. In case of failure to join within stipulated time period, the appointment shall be deemed to have been cancelled abinitio without further notice in terms of the circular instructions issued by GAD vide No. 08-JK (GAD) of 2019 dated 04/12/2019;

The Chief Education Officer, Baramulla shall allow the candidate to join on the post after observing all the conditions of appointment order and after verifying the following certificates (in original)

- All Academic/Technical Qualification certificates.
- Permanent Resident Certificate.
- Category Certificate.
- Age and health certificate.
- Discharge certificate from the Institution attending / last attended.
- Certificate from District Industries Centre/Employment Exchange to the effect that no loan under self-employment scheme has been taken.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority in order to ensure that the qualifications as reflected in the selection list is according to the genuineness marks card/qualification certificate.


The inter-se seniority of the appointee in the particular grade/service shall be fixed giving due consideration to their inter-se merit in the selection list in terms of Rule 24 CCA Rules, 1956.
