- 2. That the incumbents have completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in rules 4(K) of SRO-14, Dated 15.01.1996;
- 3. That the incumbents were not under suspension or contemplated in any charge or charge sheeted under classification Control and Appeal Rules 1956 or any other rules and his/her work and behavior has remained satisfactory;
- 4. That the present In-Situ promotion shall not change affect the existing designation/ seniority/ duties of the employees;
- 5. That the benefit of the In-Situ promotion shall not be applicable, if the official has earlier foregone regular / functional promotion or will forego his functional promotion in future:
- 6. That the work and behavior of the officials has remained satisfactory during the preceding 03 (three) years;
- That before implementing the order, the concerned CEO shall ensure that the employees are holding substantive appointment and his/ her appointment is genuine, before endorsing this order to sub- office for implementation or in his/her own office.
- 8. That no time bound promotion has been accorded by the DDO/CEO at his own level in favour of any employee;
