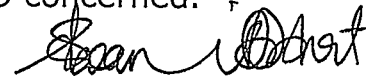
Sir

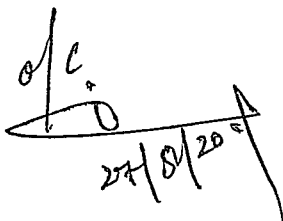
