**Subject: Final Seniority list of Qualified CPWs of District Anantnag as it stood on 01.09.2020.**

Whereas, this office vide No.: CEO/A/NT/12915-13107/19 Dated:19/07/2019 notified a seniority list of qualified CPWs for finalizing their seniority through in the Print Media and same displayed on the official website of Director School Education Kashmir ([www.dsek.nic.in](http://www.dsek.nic.in)) as well as on the official website of District Anantnag ([www.anantnag.nic.in](http://www.anantnag.nic.in)) for invitation of objections from stakeholders.

Whereas, after notifying the said seniority list, this office has received numerous representations of the concerned members for inclusion/correction of their service particulars in the aforesaid seniority list.

Whereas, the objections received in sequel to such publication stand disposed off on merits.

Whereas, a Departmental Promotion Committee's meeting was held in the Directorate of School Education Kashmir on 09/01/2020 for considering cases of qualified CPWs for regularization/absorption as Class-IV employees in District Anantnag.

Whereas, the Departmental Promotion Committee members conveyed directions that the files of all the qualified CPWs be scrutinized by a District Level Committee and final seniority list be notified.

Whereas, vide this office No.: CEO/A/NT/27516-22/020 Dated: 11/01/2020 a District Level committee headed by Deputy Chief Education Officer Anantnag was constituted for scrutinization of files of all qualified CPWs in District Anantnag.

Whereas, the said committee scrutinized all the files of qualified CPWs submitted by concerned Zonal Education Officers (All) of District Anantnag in sequel to the seniority list provided by this office and raised observations in respect of some CPWs.

Whereas, this office vide No.: CEO/A/NT/4431-521/20 Dated: 05/06/2020 again notified list of CPWs alongwith observations raised by the District Level committee on official website of District Anantnag ([www.anantnag.nic.in](http://www.anantnag.nic.in)) for inclusion/Fulfillment of observations/correction of service particulars in the said list.

Whereas, a reasonable period/opportunity was provided in respect of those CPWs who couldn't establish the genuineness of their credentials/claim.

Whereas, the observatory files of Qualified CPWs were again put forth before the committee members and the committee submitted its report and categorized the list as:

Annexure - A (Files found in order as per the parameters fixed)

Annexure - B (Files with some observations)

Annexure - C (Files not produced)

Whereas, the said committee has recommended:

1. That the qualified CPWs who have been cleared by the committee be regularized/absorbed as Class-IV.
2. That the Final seniority list of qualified CPWs be notified in the public domain and frozen once for all.
3. That the qualified CPWs who could not establish the genuineness of their credentials be given reasonable opportunity to prove their eligibility and as such the cases of such workers be put on back-burner till they establish the eligibility/veracity of their credentials.
4. That the CPWs who don't possess the requisite qualification viz. Middle Standard be ousted from the final seniority list and be placed in the list of unqualified CPWs at their appropriate positions.

Now therefore, pursuant to the decision taken by the Departmental Promotion Committee members in the meeting held in Directorate of School Education Kashmir on 09/01/2020 and as recommended by the District Level Committee, the Final seniority list in respect of 568 qualified CPWs as it stood on 01.09.2020, as per the annexure to this order is hereby issued subject to the following conditions:

- a. That the DOB of the incumbents recorded in the list is subject to further verification from original certificates of all the concerned.
- b. That the final seniority list will be subject to the outcome of writ petition(s) pending, if any, before any Hon'ble court of competent jurisdiction on the subject.
