# Subject: - Management of children with Autism Spectrum Disorder, Dyslexia and other slow-learning issues.

To review the Departmental initiatives for inclusion of children with learning disorder particularly Autism Spectrum Disorder, Dyslexia and other problems of slow-learners, a meeting under the Chairmanship of Director School Education, Kashmir was held today on 23.03.2016 in his office chambers.

Director, School Education, Kashmir informed the house that excessive focus on management of children with physical disabilities has completely ignored the children with learning disorders and children with ASD, Dyslexia, ADHD etc. are not getting due attention and very less work has been done in this field so far.

The IED Co-ordinators informed that about 500 ASD / other mentally retarded children have been identified in various districts till now field surveys. Accordingly it was desired that: -

- I. Dr. Rabia Naseem, Research Officer, SIE, Srinagar is nominated as Divisional level Nodel Officer to co-ordinate all available departmental initiatives for implementing the Inclusive Education component for such special children.
- II. The said Nodal officer shall be equipped with adequate resources and telephone helpline for facilitating the IEC activities on this subject.
- III. A committee of following officers under Principal, SIE, Srinagar shall be constituted to oversee identification of school children with various learning disabilities (dyslexia and ADHD).
  - 1. A representative from Government College of Education, Srinagar.
  - 2. Dr. Mansoor Ahmad, MD, Department of Psychiatry, SMHS Hospital, Srinagar.
  - 3. District Coordinator, IED Budgam, Pulwama & Srinagar.

# Rehabilitation plan:

- A special proforma shall be devised for preparing a check list of indicators for identification of children with ASD / other learning disabilities to be verified by DSEK for public awareness.
- ii. DRG's / IED Co-ordinators shall workout an individual rehabilitation plan for each identified child which shall also include physical rehabilitation.

# **Trainings:**

To update skills of DRG's /IED Coordinators / DRP's handling ASD / Dyslexia children a special workshop shall be conducted in College of Education, Srinagar. Mr. Wasim Tramboo has been kind enough to arrange Resource Persons from outside the State for the purpose. Prof. Seema Naz shall coordinate the arrangement.

### Additional Human Resource:

In order to ensure that adequate number of Resource Persons are available for implementation of individual rehabilitation policy in the field, Chief Education Officers (CEO) shall identify (05) Masters / Teachers preferably females for utilization of their services in District Resource Centres making these centres truly functional. The IEC Coordinators shall assist CEO's in identifying trained teachers for this purpose.

#### Other decisions:

- In order to ensure that relaxations / facilities available for such children at State and National Level are extended to the school children of Kashmir Division, a committee of following officers under the Chairmanship of <u>Principal</u>, <u>DIET</u>, <u>Sopore</u> is constituted to examine the available facilities / relaxations / academic interventions and to make the facilities compatible with CBSE / NCERT:
  - i. Two Field Supervisors from SIE.
  - ii. Two DRG's Budgam & Baramulla.
  - iii. District Coordinators from Kupwara, Srinagar & Pulwama.

2. Concession / exemptions available in BOSE for such children shall be brought into the notice of CEO's / Head of Institutions through formal means and also by public notice for 8<sup>th</sup> class. It was noticed with displeasure that few Principals do not admit children with such needs in their Institutions in 9<sup>th</sup> / 11<sup>th</sup> class. The CEO's / Principals are put on instruction to ensure that (CWSN) are admitted without hassles.
