- ii) That in case of non- teaching staff, there is no adverse entry in their service records and Personal Folder with respect their working, character antecedents and general aptitude towards Govt. work.
- iii) That there is no case pending against the subject(s) either in Police Station or in Crime Branch or in CBI or in Court of law.
- iv) That subject(s) are working on Recurring-Plan Posts.
- v) That verification vis-a-vis genuineness of the qualification and other certificates from the concerned issuing authorities is obtained and is found satisfactory.

The concerned Drawing and Disbursing Officers will ensure that confirmation entries are recorded in the service books of Teachers / Junior Scale Stenographers / Junior Assistants/ Junior Librarians/ Library Assistants / Laboratory Assistants working under their supervision after assuring the fulfillment of the above conditions.
