## CIRCULAR.

It has been time and again observed that the Chief Education Officer concerned, while submitted IN-SITU promotion cases of Teaching Personnel to this Directorate entirely rely upon the feedback of the drawing and disbursing Officer concerned without verifying/ consulting records and examining them at their own level, with the result the recommended list is entirely different from the final In-SITU promotion orders issued by this office.

Further, the CEO's/DDO's, while examining the qualification certificates (especially in the case of RRT's) rely upon statement of the officials instead of approaching the concerned College/University for ascertaining mode of acquiring such degree.

It is, as such, therefore, impressed upon all the CEO's DDO's to examine In-Situ promotion cases properly with reference to original service records before submitting to this Directorate and only recommend cases upon satisfaction of the conditions laid down in SRO-14 of 1996, in consolidated form along-with soft copy.

A re-devised format for submitting In-situ promotion cases in further is enclosed in absence of which In-Situ promotion cases shall not be entertained.
