Whereas, this office subsequently forwarded the instructions of Adm. Department to all Chief Education Officers for strict adherenace of guidelines by concerned authorities & HOI's of (Govt. + Pvt.) Schools under endorsement No: DSEK/GS/54/Misc/2020 dated: 04/06/2021.

In view of the above, the concerned Chief Education Officers are once again instructed to ensure implementation/strict adherence of the orders issued from time to time in letter and spirit and also get the complaints; lodged against the Private schools, redressed in the Special Cells constituted for redressal of grievences of the complainant in the time bound manner.
