Attention of all Chief Education Officers of this Directorate is invited towards the Government Order No: 34- Edu of 2019 Dated: 31.01.2019 (Copy Enclosed) issued by Director Finance School Education Department regarding payment of salaries in favour of untransitted RRET's. In this regard, RRET's are to be paid their salaries under 7th Pay Commission after their transition to Teacher Grade II.



Subject: Release of Salary Arrears on account of Implementation of 7th Pay Commission.

To streamline the Samagra Shiksha ReT Cadre of teachers, a separate cadre of Teacher Grade-II has been created with above referred SAC Decision and Government Orders. Besides, a scheme of transition of Samagra Shiksha Regularised ReTs to the Teacher Grade-II has also been notified vide Government Order No: 23-Edu of 2019 dated: 22.01.2019.

The whole transition exercise is expected to take some time due to transfer of responsibility of drawl of salary from office of the State Project Director, Samagra Shiksha to the office of Director School Education. Besides, the pay of officials is required to be fixed under 7th Pay Commission w.e.f 1st September, 2018. However, these teachers are without salary for last five months and clamouring hard for early release of salary, as the exercise may take longer time.

In view of the above, it is hereby ordered that pending salary of all RReTs since 1st September, 2018 shall be drawn through the State Project Director, Samagra Shiksha as per existing procedure based on the last pay drawn by the concerned RReTs. The salary arrears after pay fixation under 7th Pay Commission grades w.e.f 1st September, 2019 shall be drawn by their respective DDOs by treasury drawl immediately after their transition to Teacher Grade-II and shall be remitted directly to their bank accounts. Efforts shall be made to complete this exercise by or before 31st March, 2019.
