Attention of all Chief Education Officers and Principal DIETs of this Directorate is being sought in light of the Circular issued by Finance Department vide no: A/56 (2014) Dated: 11.02.2021 regarding payment of House Rent Allowance and recovery of rent thereof. In this regard, it is hereby reiterated that no HRA is admissible to any such Government Employee who is allotted Government accommodation. It is also clarified that in case any amount of HRA has been paid to such Government employee who is residing in any Government accommodation, such amount shall be recovered from the concerned employee forthwith.

It is further enjoined upon all Government employees who have been provided Government accommodation by Estates, or other departments, have to pay rent of that accommodation to the Estates Department.

As such, all Principal DIETs and Chief Education Officers are accordingly requested to direct the DDOs under their administrative control to ensure the following: -

1. Recovery of HRA which has been wrongly paid to Government e nployees while in possession of Government accommodation in violation of rules especially the list enclosed with the Circular.

2. The rent of the accommodation is deducted from the salary of the employees in monthly pay bills.
