Whereas, you were deputed to Government College of Education Srinagar for undergoing B.Ed course by the Department vide Govt. Order No. 2733 DSEK of 2009 Dated: 16/03/2009 and relieved by the DDO concerned on 20/03/2009.

Whereas, the Principal college of Education vide letter dated: 27/06/2009 intimated that you joined the Course/college on the same date viz 20/03/2009 and remained unauthorizedly absent from its College w.e.f. 21/03/2009.

Whereas, you were provided enough opportunities to resume your duties for which several notices were issued and published in Daily Aftab in its Edition Dated: 10/07/2012, 31/07/2012, 19/08/2012, but no response was noticed from your side.

Whereas, the final notice was issued on 15/05/2014 which you replied but the reply was found unsatisfactory and unsubstantiated by any documented evidence.

Whereas, memorandum was also issued to you by this office vide communication dated: 01/07/2019 for initiating action against you for remaining on un-authorizedly absent from your legitimate duties in terms of J&K Civil Services (Classification, Control and Appeal) of 1956 and you were asked to reply to the charges leveled against you within 07 days on the receipt of Memorandum.

Whereas, no doubt you replied the Memorandum/charges leveled against you but was found unsatisfactory and unsubstantiated by any documented evidence.

Whereas, remaining on un-authorizedly absent from duty by a Government Servant attracts action as warranted in terms of Article 113 of J&K Civil Services Rules (Volume I) of 1956.

Now, before action under Article 113 of J&K Civil Services Rules (Volume I) of 1956 is initiated against you for remaining on un-authorized absent from your duties w.e.f. 21/03/2009, an opportunity is hereby provided for hearing you and your statement of defense must reach to this Directorate within 10 days after receipt of this notice, failing which it shall be construed that you have nothing to say in this regard and proposed action shall be initiated against you without further notice.
