Whereas, vide SSB's letter No. SSB/Secy/Sel/Mig/Kul/1st/2017/10957-59 Dated 18.10.2017, conveyed by Administrative Department vide letter No. Edu-I/76/2017 dated 10.01.2018 selection in respect of Chetna Pandita D/o Satish Chander Pandita figuring at S.No. 15 under OM Category has been released;



Whereas, the Administrative Department vide letter No. Edu-I/56/2017 dated: 17.04.2017 forwarded the selection list of candidates selected as Teachers in **District Cadre Bandipora, Anantnag, Ganderbal, Pulwama and Kupwara** in pursuance to SSB's Advertisement Notification No. 01 of 2012 dated 19.07.2012, against Item No's 005, 001, 017, 029 & 025 respectively under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/787-94 dated 19.01.2017 against Notification No. 01 of 2012 dated 19.07.2012;

Whereas, vide various notifications issued through Information Department, these selectees were informed to submit the requisite papers in the Directorate of School Education Kashmir within a stipulated time and accordingly provisional appointment orders were issued in their favour;

Whereas, as many as **Eighteen** candidates in different district cadres failed to submit their papers in response to various notifications issued from time to time by the Directorate;

Whereas, the matter was taken up with the Administrative Department vide this office letter No. Estt-III/B-Trs/PMP/Sel/7015 dated 13.10.2017 and in turn the Administrative Department vide communication No. Edu-I/56/2017 dated 18.12.2017 conveyed approval for operating waiting list against the slots which become available after giving final opportunity to all such candidates who failed to join the Department so far;

Whereas, in pursuance to the instructions of the Administrative Department, all these **Eighteen (18)** candidates were given final opportunity vide this office notice No. Estt-III/B-Trs/PMP/017/64-70 dated 08.01.2018 for submission of their papers, failing which it shall be presumed that they are not interested to join the Department and the resultant slots shall be filled from the wait list, without any further notice;

Whereas, in response to the final notice, only one candidate from District Cadre Kupwara submitted his documents for issuance of provisional appointment order in his favour, and rest **Seventeen** candidates showed no response and failed to deposit the requisite papers within the stipulated time period, whose District-wise break-up is as under:-
