Whereas, the Administrative Department vide No. Edu-I/288/2014 dated 19.08.2014 forwarded the selection list of 396 candidates selected as Teacher District Cadre Anantnag pursuant to the selection made by the SSB vide No. SSB/Sel/Secy/014/6321-27 dated 23.07.2014:

Whereas, among others, selection in respect of one candidate namely Zahida Kousar D/o Mohd Bashir R/o Dandipora Anantnag figuring at S.No. 16 under ST Category was kept withheld by SSB for want of production of Bonafide certificates of PG/Pre-marital ST and PRC certificates;

Whereas, on failing to produce the documents before the SSB, her selection was cancelled vide SSB's Order No. 1314-SSB of 2016 daed 01.09.2016, convyed by the Administrative Department vide letter No. Edu-I/288/2014 dated 06.10.2016;

Whereas, the candidate figuring at S.No. 1 in the Waiting List, namely Firdous Ahmad Khan S/o Ab. Gani Khan R/o Sundbrari, Kokernag District Anantnag approached the Hon'ble High Court through the medium of SWP No.939/2017, titled Firdous Ahmad Khan Vs State and Ors. for seeking directions against the respondents to select and appoint the petitioner on the post of Teacher in the District Cadre Anantnag against the slot of Zahida Kousar D/o Mohd Bashir R/o Dandipora Anantnag figuring at S.No. 16 under ST Category whose recommendation was cancelled by the SSB;

Whereas, the Hon'ble High Court vide order dated 03.06.2017 in MP No. 01/2017 filed in SWP No. 939/2017 has been pleased to direct as under:-

"Application is disposed of by providing that respondents may consider claim of petitioner for the post of Teacher in District Cadre Anantnag, in view of cancellation of selection of private respondent. In strict accordance with rules occupying the field, provided there is no legal impediment and petitioner is otherwise eligible".

Whereas, in compliance to the Hon'ble Court order, the SSB vide Order No. 323-SSB of 2017 dated 28.8.2017 conveyed by Administrative Department vide letter No. Edu/L/K/104/2017dated 06.10.2017 recommended the selection of the petitioner namely Firdose Ahmad Khan S/o Ab.Gani Khan R/o Sundbrari Kokernag District Anantnag, earlier figuring at S.No.1 in the waiting list under ST Category by placing him in the selection

zone at S.No. 21 under ST Category consequent upon cancellation of withheld selection of Zahida Kousar figuring at S.No. 16 in the selection list of teachers under ST Category in District Cadre Anantnag;

Now, therefore, in view of the recommendations of SSB/Administrative Department conveyed vide aforementioned communications, Firdose Ahmad Khan S/o Ab.Gani Khan (whose full particulars are reproduced below) is hereby informed to deposit his undertaking duly attested by the 1st Class Judicial Magistrate on the devised format "Annexure A" alongwith all original certificates/testimonials with a set of self-attested Xerox copies (in person) in this Directorate within Seven (07) days from the date of publication of this notification.
