Commissioner concerned on the devised format available on the official website of Directorate of School Education (<a href="www.dsek.nic.in">www.dsek.nic.in</a>) upto 30th November-2017 and no application form shall be entertained after the expiry of scheduled date. Further, no Coaching Centre shall operate unless the formal registration is issued in their favour.

The district level Committees are requested to carry the inspection of these Coaching/Tuition Centres in their districts and furnish inspection report/s with concrete recommendations in respect of each application to this Directorate to consider grant of registration to the Coaching/Tuition Centre upto 15th December-2017 strictly in accordance with the provisions of Government Order No. 435 Edu of 2010 dated:- 30-04-2010.
