In case the Reserved Category Certificate(s) furnished by any official is found to be false/fake later on, the same shall be deemed to have been cancelled ab-initio and all the benefits which the official(s) would have availed on the basis on such false/fake certificates shall stand withdrawn from the date of receipt of such benefits by him. Besides, appropriate disciplinary action under rules shall also be taken against him.


