NOTIFICATION

Whereas, the Administrative Department vide letter No. **Edu-I/332/2017** dated **10.07.2017** forwarded the list of **08 candidates** selected as Teachers for District Cadre Kupwara pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Secy/Sel/2017/5270-76 dated 09.06.2017 and advised to issue appointment orders only after fulfilling of certain formalities;

Whereas vide this office Notification No. DSEK/Estt/III/B-Trs/6646-49 dated 07.09.2017, these selectees were advised to deposit the requisite papers in this Directorate within a period of 15 days, however, only **One (01)** candidate responded to the notification leaving **07** candidates who failed to do so;

Whereas the matter was taken up with the Administrative Department vide this office letter No. Estt-III/B-Trs/7817 dated 21.12.2017 for conveying necessary instructions;

Whereas, the Administrative Department vide letter No. Edu-I/332/2017 dated 15.03.2018 conveyed instructions for operating waiting list against the slots which became available due to non-joining of candidates for the post of Teacher in District Cadre Kupwara in pursuance to Advertisement Notification No. 03 of 2014 dated 30.12.2014 under Item No. 319 ;

Whereas, against 07 non-joining candidates, only **Three** candidates have been recommended in the Waiting List, out of which recommendation in respect of **Kulbushan Kumar S/o Teak Raj R/o Shareena Khurd Doda** figuring at **S.No. 1/Wait** has been kept withhld by the SSB, for want of production of bonafide PG certifiante, as such only **Two** candidates can be considered for provisional appointment;

Now, therefore, the below named **Two (02)** candidates who are existing in the waiting list issued by SSB against District Cadre Kupwara (Notification No. 03 of 2014 under Item No. 319) and whose selection has not been kept withheld by the SSRB are hereby informed to deposit their undertakings (duly attested by the 1st Class Judicial Magistrate) on the devised format "**Annexure A**" alongwith their original qualification and category certificates in the Directorate of School Education Kashmir within a **period of 10 days** from the date of publication of this notification. No such documents shall be entertained after expiry of the stipulated time frame.
