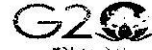

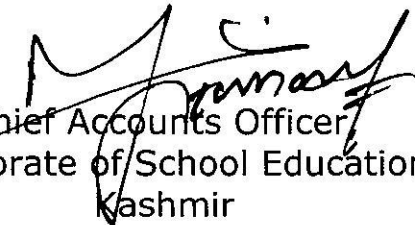
Sub:- In-situ promotion cases of Teaching/Non-Teaching officials.

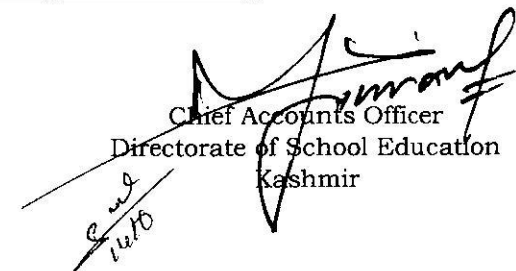
