It has been reported that a number of Private Schools have not adhered to the conditions as laid down in SRO 123. Excerpts of the said SRO with regard to Physical facilities/Teaching staff of Middle Schools are reproduced

Physical Facilities:

here-under:-

vii.

- "The School shall be located in a noise-free zone and shall have:i. a minimum of three rooms with an average space of 1-2 Sq. Mts. per
- student each for class 6th, 7th and 8th. If the Middle School has also preprimary and primary Classes, additional accommodation to that extent to be-provided.
- ii. each class room to have at least one seat and writing space for each student.iii. one library.
- iv. one room for indoor-games (with an area of not less than 150 Sq.Mt.)
 v. one Multi-purpose Educational Laboratory (with an area of 150 Sq.Mts).
 vi. one Principal's room (with 100 Sq.Mt. area).
- viii. separate toilet and drinking water facility for the students (boys and girls) besides for the staff.

one staff room (with 100 Sq.Mt. area).

- ix. if the intake of students is above 50 per class, an extra section be added.
 x. examination Hall (of appropriate dimensions, depending on the enrollment)
- enrollment).

 xi. if the school has also pre-primary to class VIII, additional infrastructure to that extent be provided.

Teaching and Other staff:

A minimum of eight teachers, at least two of whom should be trained graduates besides a Head Teacher/Principal/Headmaster."

It is impressed upon all Heads of the Private Schools (Pre-Primary to

Middle standard) to implement the SRO 123 in letter and spirit. Violation of SRO 123 shall entail de-recognition of the School.

Deficiencies, if any, should be completed within a period of two months

i,e up to August 09'2012. Thereafter, any negligence, disobedience, if observed on the part of Head of the Institution/Management, the recognition of the School/(s) shall be withdrawn without giving any further notice and the parents of the wards will be asked to withdraw their wards from the School/(s).

All Chief Education Officers are required to keep a strict vigil over the activities of the Private Schools in their respective districts for implementation of SRO 123 in its right perspective.
