Sub: Withdrawal of transfer and adjust order of Class-IV officials of District Pulwama.

**ORDER**

Whereas, interms of SRO. 308 of 2008, dated. 16/10/2008, Lab. Bearer, Chowkidar, Sweeper, Gardner, Library Bearer, Cleaner, Gasman etc. though are in same category of posts but their nomenclature and nature of Job is equally different and each post has separate cadre sanctioned strength in the Department even Laboratory Bearer, Gasman enjoys vacational status under CSR;

Whereas, it has come to the notice of this Directorate that CEO, Pulwama vide his office order No. CEO/Pul/NT/17/5500, dated. 18/09/2017 has issued inter-cadre mass transfer of 110 Class-IV in violation of norms against the Cadre Management without approval of higher authorities;

Whereas, the representatives of the effected Class-IV of District Pulwama have approached to the Directorate for redressal of their grievances and requested to direct the CEO, Pulwama for withdraw of their transfer order issued in violation of norms;

Whereas, Dy. Commissioner, Pulwama vide his office order No. DCP/PA//17/1636-38, dated. 23/09/2017, has put some part of the order in abeyance and Hon'ble Minister of State for Forest Ecology and Environment, Animal, and Sheep Husbandry, Cooperatives and Fisheries, has also asked for some modification in the order;

Whereas, CEO, Pulwama vide this office communication No. DSEK/NT/Trans/19/446-2017/1565, dated. 05/10/2017, was advised to withdraw the transfer order and circular forthwith under intimation to this Directorate to keep intact the cadre Managment and job profile of such Class of posts;

Whereas, Govt. order No. 74-Edu of 2017, dated. 27/02/2017, (i.e assignment of duties to Joint Directors of Education Department endorsed among others to all CEOS vide No.DSEK/GAZ/71, dated. 06/04/2017), read as :-

**"It is also ordered that Chief Education Officers shall effect transfers in consultation with the joint Directors. Further, Joint Directors shall be members of all Divisional Level Promotion Committees".**

Now therefore, in exercise of powers vested to me under Govt. Order No. referred to herein above. The inter cadre transfer order of 110 Class-IV issued in violation of norms against **cadre management** without seeking proper approval of higher authorities by CEO, Pulwama vide order No. CEO/Pul/NT/17/5500, dated. 18/09/2017, is kept in abeyance till further orders, the Class-IV who stands relieved by the respective DDO's shall report to their previous place of postings after being properly relieved back by DDO's/Head of the institutions.
