**Subject:- Placement of eligible trained-graduate / trained post-graduate Teachers for promotion as Incharge Masters / Head-Teachers.**

**ORDER NO. 928-DSEK of 2013  
DATED 30 / 03 / 2013**

Whereas, pursuant to the approval by the Departmental Promotion Committee in its last meeting held on **05/01/2013**, the Department promoted **353** trained-graduate/grained post-graduate Teachers as Masters/Head-teachers against available slots in Kashmir Division including District Kargil vide Order No. 497-DSEK of 2013 Dated 19/02/2013

Whereas, after issuance of the said promotion order, the office received number of objections/representations from the concerned stake holders who have not been included in the said order due to non-production of their service bio-data;

Whereas, after examining the observations made by the representatives **06 (Six)** Teachers were found drop-outs of promotion Order No. 1589-DSEK of 2012 Dated 25/08/2012 and **41 (Forty one)** officials of Order No. 497-DSEK of 2013 Dated 19/02/2013;

Whereas, the Chief Education Officers were asked by this Office to furnish vacancy position of Masters/Head-Teachers including the posts becoming available due to upgradation of Schools under RMSA Scheme;

Whereas, the Chief Education Officers concerned have communicated the vacancy position of Masters/Head-Teachers which have been consolidated and accordingly **1709** vacancies were identified;

Whereas, the Hon'ble Deputy Chief Minister (Minister for Education Department) conveyed the instructions to fill-up the vacancies of Masters/Head-Teachers by placement of eligible trained-graduate/trained post-graduate Teachers;

Whereas, upon examination of the issue it was revealed that the service bio-data of some Teachers are still awaited from the concerned Chief Education Officers for which some vacancies of Masters need to be kept reserved and the service bio-data of the Teachers proposed to be promoted/placed needs to be re-verified;

Now, therefore, without prejudice to inter-se seniority, out come of Court case pending before any Hon'ble Court, sanction is hereby accorded to the placement of **1500 (One thousand and five hundred)** eligible trained-graduate/trained post-graduate Teachers as Incharge Masters/Head-Teachers in their own pay and grade as a stop-gap arrangement in view of academic necessity on the available posts in the Districts to be ordered separately as per **Annexure** to this Order, pending ratification by the Departmental Promotion Committee and verification of service bio-data and other eligibility as required for such placement by the concerned Chief Education Officer / Drawing and Disbursing Officers and subject to the following conditions:-

- that in case of any discrepancy in the service particulars of any official is reported any official is found not to be eligible for such placement, this order will not confer any right upon the official and the placement shall be deemed to have been rescinded abintio in that case;
- that in case any eligible Teacher does not found his name included in the said placement order he/she could be considered also giving the effect of placement from the same date his/her counterparts were considered as such;



- that the placement of Teachers as Incharge Masters/Head-Teachers made under this Order is without prejudice to the superior claims if any. The inter-se position assigned to the officials in the Annexure to this Order, or other orders issued from time to time, shall be liable to be re-determined separately on facts/merits/superior of each case;
- that in case of any adverse report from Vigilance Organization, the placement of the concerned Teachers shall be cancelled without prior notice;
- that the officials must necessarily be holding substantive appointment and un-interrupted service, it must be ensured that none of the officials in the list is working as Migrant substantive/un-recognized/FAT/Fake/Adhoc basis. The benefit of placement shall not be allowed in case of such a Teacher who is under suspension or against whom departmental proceedings may be pending or whose work and conduct is not be satisfactory;
- that the officials must have passed B.Ed./M.Ed. examination before the date of placement through a **Recognized University** after observing all departmental formalities
- that the placement shall be without prejudice to the final outcome of the court case, if any pending before any subordinate court or the Hon'ble High Court and other orders, if any passed by the competent authority which are not immediately within the knowledge of this Directorate;
- that the posting orders will be issued in respect of only those officials in whose case all above conditions are fulfilled by the respective Chief Education Officers/Drawing and Disbursing Officers;

The Chief Education Officer/Drawing and Disbursing Officers concerned are impressed upon to give wide publicity to the placement order and in case any objection is the same may be communicated to this Directorate within **15 (Fifteen) days** from the date of issuance of the placement order and no such claim/objection can be entertained after the given time.
