
The In-Situ promotion cases of teaching officials appearing in the Annexure of this letter could not be settled due to incompleteness/ discrepancies of documents as indicated against each.

- In case of clarification regarding mode of passing degree(s) during honorarium/ regular service, documentary proof (degree certificate or any other proof) be appended and entry to this effect be also recorded in Service book (under proper seal and signature of DDO Concerned).
- The case of SSA RRT's, the clarification/ documentary be submitted only when such cases are considered.
- Certificate of the CEO concerned to the effect that there is no criminal enquiry / proceeding, pending against the official before any investigating agency viz;(VOK/Crime branch) or court of law and the genuineness of appointment has been ascertained established in respect of the employee/s.

Moreover, you are requested to furnish fresh attested Xerox copy of service book of each official in each observation case with your clear recommendations instead of simply endorsing the report of DDO concerned.


