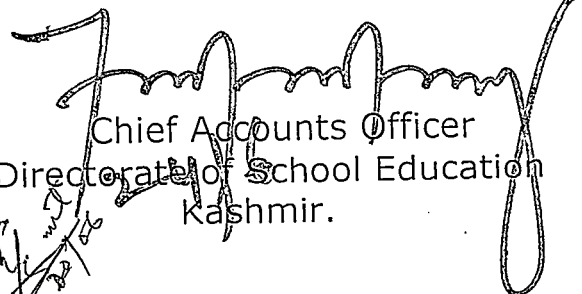

- Certificate of the CEO concerned to the effect that there is no criminal enquiry / proceeding, pending against the official before any investigating agency viz;(VOK/Crime branch)or court of law and the genuineness of appointment has been ascertained established in respect of the employee/s.

Moreover, you are requested to furnish fresh attested Xerox copy of service book of each official in each observation case with your clear recommendations instead of simply endorsing the report of DDO concerned.
