
The list of Teaching officials appearing in the annexure of this letter could not be settled due to the observation/ Documents as indicated against each.


You are accordingly requested to furnish clarification along-with supporting documents adopting the following procedure.

The cases shall be submitted in separate file covers with not clubbed together.


