**Sub: Issuance of Termination Notice**

Whereas, among others you were provisionally appointed as Teacher in District Cadre Srinagar (under PM's Package) vide this office Order No. 897 DSEK of 2018 Dated: 07/07/2018 pursuant to the selection/recommendation made by the JKSSB and in light of instructions conveyed by the Administrative Department vide their communication dated 27/04/2018 wherein your particulars were reflected as under:-



Whereas, you were subsequently posted in High School Panthachowk by the Chief Education Officer Srinagar on 02/08/2018, giving the joining date as 12/07/2018; and

Whereas, after verifying your testimonials/documents from the issuing authority, the Chief Education Officer recommended the case for issuance of formal appointment order vide his communication No. CEO/Sgr/Estt/Apptt/5378 dated: 29/05/2019; and

Whereas, your provisional appointment order, among others, was confirmed by this office vide order No. 551-DSEK of 2019 dated :19/07/2019 with the condition that the order shall be implemented after fulfillment of all terms and conditions as laid down in the provisional appointment order; and

Whereas, the Chief Education Officer, Srinagar vide his communication No. CEO/Sgr/Estt/3498 dated: 18/03/2020, reported that your marks certificate of BA Part-III was re-verified from the University of Jammu by the Drawing and Disbursing Officer and was found "FAKE"; and



Whereas, pending enquiry into your conduct, you were placed under suspension and attached with Directorate of School Education Kashmir with immediate effect and subsequently Mr. S.D.Bhat Joint Director (SAMAGRA) was appointed as Enquiry Officer to conduct preliminary enquiry in the matter vide this office order No. 352-DSEK of 2020 dated 29/10/2020; and

Whereas, the Enquiry Officer has furnished its report on 16/08/2021 and has established that you have managed your selection through JKSSB by production of **FAKE B.A. Part-III** marks certificate (under Roll No. 107766 through Jammu University). Further it has been stated that you have deceived the Department and drawn huge salary from the Government Ex-chequer w.e.f. 07/07/2018 to 31/01/2020 fraudulently; and

Whereas, on examination of the issue it was observed that you have deceived the Department by producing **fake & fraud B.A. Part-III** marks certificate on the basis of which you managed your selection through JKSSB as Teacher in District Cadre Srinagar (under PM's Package) for Rehabilitation of Kashmiri Migrants on 07/07/2018 and as such it was observed that your confirmation to the provisional appointment need to be rescinded and simultaneously action as warranted under law will be initiated against you; and


Whereas, your confirmation to the provisional appointment order stands withdrawn by this office vide Order No. 685 DSEK of 2021 dated: 20/10/2021.

Now, you are hereby given an opportunity to show cause as to why your services shall not be terminated and the same shall reach this Directorate within 07 days from the date of issuance of this notice failing which it shall be construed that you have nothing to say in your defence and action as warranted under rules shall follow without any further notice.
