Verification of qualification in the discipline of Chemistry.

Sir/ Madam.

The department is contemplating to elevate eligible Masters/ Teachers in the discipline of Chemistry as I/C Lecturer. In this connection, I am directed to forward herewith a list of Masters/ Teachers in the discipline of Chemistry and request you to kindly conduct verification of certificates of the candidates by constituting dedicated verification cells for the purpose. A notice be published within two days, in atleast two leading news papers of the division asking the incumbents to get their PG Marks certificate/ Degree verified by the Directorate within a period of 7 days, failing which it will be presumed that the official is not in possession of a valid PG Degree and his/ her name shall be deleted from the seniority list of PG Masters/ Teachers in the discipline of Chemistry. They may also be asked to submit necessary proof with regard to permission for acquiring their PG in case they have done their PG during their service carrier.

Consolidated information should be furnished to the Administrative Department by 20.10.2015 alongwith newspaper cutting published and all relevant documents pertaining to the subject. While forwarding the verification, it may clearly be mentioned as to whether the Degree has been obtained as a regular candidate or through distance mode or from study centre. It may also be intimated as to whether the Degree has been obtained from a recognized University.
